The Pastor's Quarter



Dear Friends in Ministry,

I am reaching out to you this day to ask for your prayers and wisdom, as I struggle with anxiety. Initially, I thought there was something wrong with my health, and underwent a thorough medical examination. While I was glad to be declared "healthy" I still did not trust my own mind. For example, I find myself going into another room, and forgetting why I went into the room in the first place.

It has also affected my leadership in the service of worship, as I find myself skipping parts of the service on Sunday mornings. Needless, to say, it has troubled me as much it has the members of our shared

ministry.

Recently, I met with the Pastor Parish Relations Committee in Montevideo, and they have encouraged me to share with you that I'm struggling with anxiety.

Admittedly, it is a difficult task. I feel as if my mind has failed me, but I'm discovering that I'm not alone in my struggle with this condition. Having named this challenge, I have already identified several approaches to restoring my health. Part of my care plan is continuing to meet weekly with a counselor at Woodland Center in Willmar. In addition, I will also seek a spiritual counselor that I too might ask the eternal question, "Why me?"

"In addition to my regular counseling sessions, I have daily sessions practicing relaxation/meditative techniques and reflective journaling and I take care to get physical exercise. I know my path to healing will be difficult and it will take time. In the meantime, in order to improve the delivery of services under my circumstances, I am also working with some members of the congregation and Danielle, our new church secretary, to explore how to lay out service materials in ways that work better for me. And, I have begun the practice of rehearsing services, including special services like weddings and memorial services, with someone who critiques me and gives me feedback."

Finally, I have been in conversation with the Minnesota Conference of the United Church of Christ, and I trust that our colleagues in ministry will share their insights and resources.

If you would like to sit down and share a moment, I would greatly appreciate your company.
