FROM OUR MODERATOR

Our Transitioning Church: A Message and an Appeal From Your New Church Moderator

Our church is in a transitional period and it is important for everyone to understand the sequence of developments and decisions that brought us to this juncture. For the past number of years the Granite Falls United Church of Christ and the Montevideo First Congregational United Church of Christ have operated under the terms of a Shared Ministry Agreement. That umbrella agreement facilitated a separate contract of compensation for a called pastor to serve both churches. Under that contract both churches would contribute equally financially and share equally in the pastoral services. These are the agreements that were in place during Dan Maiden's ministry. In November, 2017 the Montevideo church withdrew from the Shared Ministry Agreement and Dan's ministry in Montevideo was brought to a negotiated conclusion.

The Montevideo decisions had obvious consequences for our church and this was addressed at our January 24, 2018 annual meeting. At that meeting our membership was asked to decide whether our church, acting alone, wished to enter into a new contract with Dan. The church council, in consultation with Dan, established a threshold of affirmative ballots sufficient to indicate our willingness to do that. At the time the ballots were cast it was understood that a new contract mandated by a yes vote would have to be consistent with our proposed budget for 2018 and that the proposed budget would allow for only part-time ministry. The voting membership also understood that a no vote would leave us without ministerial leadership and send our church down an uncertain path. The balloting did not meet the established threshold, a new contract was not offered, and now we are traveling that uncertain path.

Not only is this a transitional time for our church, it is also a transitional and difficult time for Dan. We are keenly aware of this and the church council has taken action that will hopefully help Dan secure his future. We will honor our church's half of the compensation package as originally negotiated until the middle of May. It is our hope that this will allow Dan to move forward with a measure of security. We extend our thanks to Dan for his service to us and we wish him well.

The 2018 annual meeting also brought an end to Spencer Kvam's three-year tenure as church moderator and I have succeeded him in that position. I accepted this position with some reluctance because I understand that our way forward is not going to be easy, but having accepted the position I promise to do my best to help lead this church. Fortunately, I do not lead alone. There are many talented people in our church that have already helped me in many ways and that gives me confidence.

I have faith in our church. Our church has a future and we are already navigating our way into it. We just recently opened our doors to the community for our annual meatball dinner and the community was very generous in their support. Our membership stepped up with great leadership and enthusiasm to make the dinner a big success. We will be holding soup and bread meals as well as devotions at 6:00 pm on Wednesday evenings during Lent. For those Sundays when we have not been able to secure pulpit supply, church members have volunteered to lead our worship and their willingness to help carry our church forward is very much appreciated.

Now for the hard part. What is your role? Lent is an appropriate time for all of us to reflect on what our Christian faith and our church community mean for us. Come at 6:00 pm for soup, bread and devotions on Wednesday evenings during Lent. Prepare to celebrate the great miracle of resurrection on Easter Sunday. Reverend Rosanna Walker will lead services on both Palm Sunday and Easter Sunday as well as the first Sunday of each month starting March 4th. Allen Gislason will lead our service on March 11th. Come and fill the church as a visible gesture of your faith and commitment.
